Beginning with the date signed by the undersigned, through June 8, 2007, the undersigned does hereby give permission for an authorized representative of the Del City Church of Christ Rock Creek Camp Session to consent to any X-ray examination, anesthetic, medical, surgical or dental diagnosis or treatment, and/or hospital care to be rendered to the child named above, under the general or special supervision and on the advice of a physician or dentist licensed under the provisions of the Medical Practice Act on the medical staff of a licensed hospital, whether such diagnosis or treatment is rendered at the office of said physician or at said hospital as needed for injuries or illness occurring during and/or immediately following the camp activities. The undersigned shall be liable and agree(s) to pay all costs and expenses incurred in connection with such medical and dental services rendered to the aforementioned child. Should it be necessary for your child to return home due to medical reasons or otherwise, the undersigned shall assume all transportation costs.

The undersigned does also hereby give permission for our child to ride in any vehicle designated by the adult in whose care the minor has been entrusted while attending and participating in activities sponsored by the Del City Church of Christ

The undersigned does hereby release, forever discharge and agree to hold harmless the Del City Church of Christ and its authorized representatives from any liability, claim or demand for personal injury, sickness or death, as well as property damage and expenses of any nature whatsoever, which may be incurred by the undersigned and the child, which occur while said child is participating in any activity sponsored by the church.
